**The Prime Minister confirms Step 4 of the Roadmap out of COVID-19 in England will go ahead on Monday 19 July.**

On 19 July, most legal restrictions will end including the removal of social distancing and social contact restrictions and remaining businesses will be able to reopen. Step 4 will mark a new phase of continued caution, whilst managing the risks of COVID-19, in our response to the pandemic.

### **New Working Safely guidance has now been published**

To support businesses and the self-employed to continue to work safely during the pandemic as we move to Step 4, we have published updated [Working Safely guidance](#). The guidance cover a range of different types of work and also includes guidance for people working in, visiting or delivering to other people's homes. You can also find [updated guidance](#) on hosting weddings, civil partnership ceremonies and other celebrations in England during step 4 on GOV.UK.

The government have also extended NHS Test and Trace's free workplace testing offer until the end of July, with 19 July as the final date to place orders. Free workplace testing will therefore now end on 31 July. After the end of July, we would encourage you to direct your employees to [pharmacy collect and online ordering](#) to continue accessing rapid lateral flow tests. As we continue returning to normal, twice-weekly testing remains key and we recommend people continue to test.



### **Prime Minister sets out new 'County Deals' in Levelling Up speech**

Speaking from the UK Battery Industrialisation Centre (UKBIC) in Coventry on 15<sup>th</sup> July, Boris Johnson set out his vision on how the government would deliver on the central purpose of his premiership – to level up and unite the whole of the United Kingdom.

As part of the speech, the Prime Minister set out the integral role for government in helping to deliver the levelling up agenda, including plans to empower strong local leaders by taking a more flexible approach to devolution, with new 'County Deals', invest in infrastructure and connectivity and more.

### **New Hospitality Strategy published to help the sector Build Back Better from the pandemic.**

Business Minister Paul Scully today (16 July) [launched](#) the first ever Hospitality Strategy to support the reopening, recovery and resilience of England's pubs, restaurants, cafes and nightclubs.

To support the industry in its reopening, the Strategy sets out measures including highlighting opportunities in the hospitality industry to jobseekers through DWP's dedicated Work Coaches and helping the sector address current recruitment challenges.

### **Expert report: every UK job has the potential to be green**

### **Business Secretary visits Stellantis' Vauxhall Ellesmere Port site as they announce plans for £110m investment**

Kwasi Kwarteng visited the Vauxhall Ellesmere Port site of multinational automotive company Stellantis on 6 July, as they announced their decision to to

manufacture battery electric vans at the site through a new £110m investment into the plant.

Speaking alongside key Stellantis executives, the Business Secretary remarked on how the investment represented a strong vote of confidence in the country's auto manufacturing sector, as well as a key development to put the UK at the forefront of the development and manufacturing of zero emissions vehicles.

### Changes to right to work checks from 1 July

Following the deadline for applications to the EU Settlement Scheme, the process for completing right-to-work checks on EU, EEA, and Swiss citizens has now changed.

Employers can no longer accept EU passports or ID cards as valid proof of right-to-work, with the exception of Irish citizens. Instead, you need to [check a job applicant's right to work online](#) using a share code and their date of birth. You do not need to retrospectively check the status of any EU, EEA, or Swiss citizens you employed before 1 July 2021.
