**Prime Minister and Business Secretary visit Nissan's Sunderland plant as Nissan and Envision announce new £1 billion investment**

The announcement represents a major expansion of electric vehicle production at Nissan's Sunderland plant, as well as a huge boost to the country's automotive industry.

As part of the investment, Nissan will build a battery "gigafactory" and a new electric car model at the plant. More than 1,600 jobs will be created in Sunderland, with an additional 4,500 more jobs estimated in the supply chain. [Find out more.](#)

## **New subsidy system to support UK jobs and businesses, boost the economy and strengthen the union**

The new Subsidy Control Bill was introduced to Parliament on 20 June setting out the UK's new subsidy control system following the UK's departure from the European Union. The Bill will allow the UK to create a new system for subsidies that can enable key domestic priorities, such as levelling up economic growth across the UK and driving our green industrial revolution.

## **End to coal power brought forward to October 2024**

The deadline to phase out coal from Great Britain's energy system has been brought forward by a whole year, highlighting the UK's leadership to drive down emissions and tackle climate change.

From 1 October 2024, Great Britain will no longer use coal to generate electricity. The move is part of ambitious government commitments to transition away from fossil fuels and decarbonise the power sector by 2050. [Find out more](#).
